

SCHOLARSHIP PROGRAM 2020 FIRST PRIZE WINNER

Congratulations to our 1st prize Scholarship winner Robert F. Williams. Mr. Williams had the unprecedented experience of being unanimously selected by all 4 judges. Williams is a Ph.D. student – Military history, Department of History, Ohio State University. Robert earned his CIB in Iraq, serving as Fire Team Leader. In Afghanistan, he served as a heavy weapons Section Leader. His 3rd tour was as platoon sergeant, 1-501st Infantry (Airborne) Khost Province, Afghanistan. Williams was honorably discharged on November 1, 2017.

ROBERT F. WILLIAMS

Describe the circumstances of the event during which the CIB was earned.

My first firefight occurred the day after Saddam Hussein was captured in December 2003. My unit came under fire from Iraqi insurgents loyal to Hussein in the city of Samarra after my platoon captured a military -aged male riding a motorcycle. I was manning an M2 .50 Caliber machine gun on a Stryker Infantry Carrier Vehicle. Usually, this weapon is fired from inside the vehicle. Yet on this day, the remote weapon system was not functioning, and I was firing from on top, providing suppressive fire. At the same time, elements of my platoon maneuvered on enemy positions. Throughout my three combat tours and thirty-six months in combat, I came under fire more times than I can count, many in some very hair-raising experiences that resulted in numerous casualties.

What makes the CIB special to What makes the CIB special to you?

The Combat Infantry Badge is special to me because it signifies my competence at the most important job I ever had—leading men in combat. Earning the CIB places a soldier in a fraternity of previous recipients that earned the badge in conditions most Americans cannot fathom. I am fortunate in that I can now apply for this scholarship, whereas many of my friends can not, as the badge was the last thing they earned.

If our government called you up for the Draft due to a military conflict, how would you respond?

After a career as an infantryman, I am afraid I would be precluded from service in the event of a draft. However, if called, I would eagerly re-enter service to apply my hard-won experience on the battlefields of Iraq and Afghanistan to whatever situation the United States needed me. I am, however, a recent addition to my local draft board in Ohio. After arriving at Ohio State University for graduate school, as I get older, I thought the best use of my experience and patriotism was to enroll as a local draft board member. Military service is a crucial component of my family's history. My father served in the Navy during the Cold War. My grandfather was an artillery officer in World War II, where he provided much-needed fire support to the infantrymen of the 96th Infantry Division in the Philippines and Okinawa. I can trace my family's

military history to the American Revolution, including an infantry Sergeant in the 4th Minnesota during the American Civil War. Needless to say, if the government called me up during a draft, I would eagerly respond and hope that I am not too advanced in age to do my part.

The United States is a unique experiment in self-governance. Far from perfect, it is a participatory democracy that requires buy-in from each citizen. Sometimes, in an existential crisis, this requires donning the uniform of one's country and pledging to defend it from all enemies—foreign and domestic. The draft, as President Woodrow Wilson once said, is the most democratic way to raise an army.

Many of the younger students had never asked their father or grandfather about their Army background or the event they endured to earn the Combat Infantry Badge. As the CIB awardee began talking to his/her family member for the very first time in all those years, about his battle experiences, about being a soldier -there was obvious wonderment from the listener that the old guy they knew who mowed the lawn and puttered around the house was once a very brave soldier who put his life on the line for his country.

There now began a higher respect for each other. From the soldier – a sense of gratitude that he could help his family member earn a scholarship award. From the listener a new found respect for the revealed battle experiences and a deep appreciation that dad or gramps actually cared enough to help his family member win a scholarship.

The Executive Board was equally impressed with the entries. Though we had only 3 awards to give out, how can you limit it to 3 if #4 and #5 are also touching. The Board thus overwhelmingly voted to extended the awardees to 5.

Also, thanks to this year's generous raffle donations the Board took the unprecedented step to adjust the award amounts. Therefore #1 stayed at \$2,500. #2 increased from \$500 to \$1,500; #3 increased from \$250 to \$750; #4 increased from ZERO to \$500; #5 increased from ZERO to \$250. And the WINNERS ARE:




Historic Growth

NATIONAL SERVICE OFFICER'S REPORT



Service Officer issues are processed by National Commander Alfred Serrato. Serrato has been a Service Officer for 12 years. He only processes Appeals. "I'm moved by soldiers and widows who I believe have been treated unjustly." His work was done primarily in Thailand. Service Officers working from Thailand cannot be "accredited" because there is no Veteran Administration presence in Thailand. Serrato only processes DENIALS related to service-connected disabilities; Denials of a CIB award; Denials of a Widow's Pension.

- April 2020. Yo C., a Thailand widow of MSgt Bill C. was denied her just claim for a Widow's Pension.
 DCAS claimed that Widow Pension payments were being made (they were actually being paid to a
 woman the soldier had divorced 10 years before). National Service Officer Al Serrato filed a claim six
 years ago. In April 2020, after years of dogged determination, she received a retroactive claim payment
 exceeding \$50,000. June 2020.
- Steve W. Service Officer Serrato successfully assisted the Army Veteran by increasing his rating to 100% using the concept of "Unemployability."
- July 2020. Judi S., a California widow of army veteran Jack Sharkey, was denied a Widow's Pension by
 the Veteran's Administration claiming her husband's death was not service-connected. Service Officer
 Serrato filed an appeal based upon the premise that the cause of death was from a condition
 Secondary to an existing and approved Service -Connected disability. In July 2020 the VA reversed their
 denial and the widow was granted full Widow's Pension Benefits.
- August 2020. Jit L. Though ten years had passed since the Widow's husband had died, she never received status on her claim for a Widow's Pension. She was near destitute. Her claim had been started but never submitted because the person helping her had Alzheimer's disease and never followed through. Service Officer Serrato was able to get a waiver for the old claim. Eventually, the widow's claim was approved and she received an award of over \$80,000. The widow brought a luggage full of old papers to Serrato who agreed to review documents. He found the "needle in the haystack." To Serrato's astonishment, he found documents confirming \$225,000 in stock with Fidelity Pension. Regretfully, the husband forgot to add his wife as Beneficiary. That claim is now being processed on behalf of the Beneficiaries.
- Service Officer Serrato is currently processing 4 applications from four 11Bravo Combat Warriors who
 have been unjustly denied their Combat Infantry Badge. Serrato is meticulously gathering supporting
 documents to support the soldiers' rightful claim.

NOTE: Any offers of assistance in researching claims would be greatly appreciated.

Legislative Report



April 2020: The National CIB Commander sent a letter of support for HR 5995/ SB 3393, The Major Richard Star Act.

Both of these bills correct the injustice that is caused when combat soldiers, who are so severely wounded in combat, are forced to retire early from the military and do not serve 20 years. These bills repeal the unfair offset of retire pay from the military being subtracted from disability compensation benefits from the VA. Retirement benefits are from the military. Disability benefits are from the Department of Veteran Affairs. They are not the same awards. One cannot be subtracted from the other.


September 1, 2020: National Commander is working with State Senator Bob Archuleta that would allow veterans with a DV License plate to ride in the Car Pool Lane. Daily, thousands of disabled veterans are driving to a VA Hospital for treatment. Many of those drivers often arrive at their VA facility late due to congested traffic and frequently can not find parking spaces available. They are often required to make another appointment.

September 5, 2020: National Commander sent a letter to the Democratic Party of Orange County California demanding that Vice Chairman, Jeff LeTourneau be removed from their Executive Board.

LeTourneau drew heated criticisms from both Democrats and Republicans for an e-mail glorifying Ho Chi Minh—the Communist leader during the Vietnam War.

Two days later, after heated debate, LeTourneau was removed as Vice Chairman.

Tomb of the Unknown Soldier



Every November 11 our annual National Veterans Day is especially observed at Arlington National Cemetery where a wreath is placed at the Tomb of the Unknown Soldier. It is a very moving, somber ceremony.

Within a few years of the end of WWI, the United States Congress discussed the importance of erecting a monument to the soldiers who lost their lives. U.S. Army General John Pershing testified before congress favoring a monument - a tribute to the Unknown Soldier who lost his life on the battlefield. Congress approved erecting the monument in 1921. The monument was dedicated to U.S. service members who died without their remains being identified. It has since evolved to honor and thank all who served in the United States Armed Forces.

The symbolism of an unknown, entombed soldier serves as a deeply profound monument for all who fell in the service to our country. The laying of the wreath is rich with symbolisms. For example, the Honor Guard marches 21 steps down the mat. "21" was chosen because it symbolizes the highest military honor that can be given – the 21 gun salute. Additionally, the Honor Guard soldier "walking the mat" does not wear rank insignia so as not to outrank the Unknown Soldier.

The tomb is guarded 24 hours per day, 7 days per week. Bad weather, even terrorist attacks do not postpone the "watch."

On November 11, 2019 the Combat Infantrymen's Association members who were selected to place our wreath at the tomb were retirees Lt. Col. Albert Guarnieri and Brigadier General James D'Agastino from CIB Company 107 – Rhode Island.
